A letter was sent to each member of the Judiciary Committee and the Montgomery County Delegation reiterating GOCA's opposition to increased speed limits on the ICC due to the exponential increase of noise and pollution to the properties adjacent the highway. The MD Senate had a Hearing on 2/7

The Planning Board held a DRC (Development Review Committee) on Feb 4 on the Trotter's Glen project.

The Planning Board will have a two hour session with the Legal Department regarding Farquhar Middle School on Feb 21 (1:30).

Connection of the North Branch Trail to either Kirk or Ridge Rd will be tricky due to topography. Will have Parks Dept present options at April GOCA meeting. If supported, it will need to be added to CIP budget.

New Zoning Code review finishes at Park & Planning in February. Implementation is next. Final draft with implementation recommendations will go to Council in May. ## A Proposal for The GOCA Foundation

February 12, 2013

**Concept**: GOCA creates a 501(c)(3) entity consistent with the Bylaws objectives ("...to promote the overall civic, economic, ... and cultural welfare of the (Olney) community...")
