DRAFT MINUTES - February 18, 2010

The meeting was called to order by President Sharon Dooley at 7:35 p.m. The minutes from the January 2010 meeting were approved. The agenda was accepted.

PUBLIC COMMENTS

When asked for public comments those present all wanted to discuss snow removal and power outages. Sharon said that she had received and also read on the Olney Brookeville Exchange many complaints of state roads not being plowed. She had contacted the legislators, State Highways directors, directors of the road crews and had mentioned to them the gridlock encountered and the abysmal job that had been done. Sharon was told of the priorities; those being hospitals, schools, etc. While we all understand the need for priorities we also feel that there should be a tiered system to deal with forgotten roads. Many of the Olney neighborhoods did not see a plow after the first storm and didn't see one until well after the second storm.

Members of the Norbeck Meadows community praised the private contactors that had handled their neighborhood. According to Arnie the private contractor had done a really great job.

Jim Haddow said that Hallowell did not see plows until the Sunday of the 2nd storm in some parts of the neighborhood and fire trucks couldn't get in to some streets.

Lori wanted on to go on record that while she understood the need and requirement to keep sidewalks she didn't appreciate comments where those living adjacent to sidewalks were called lazy and uncaring for not shoveling them clear. She reported that in Cherrywood, her neighborhood the plows had come through and plowed the snow on to the sidewalk and in some areas there was a 6ft or higher wall of ice covering the sidewalks.

It was agreed that while there were some folks that needed to take a step back and cool off, most residents of the Olney area were neighborly, kind and helpful. People had to realize this was a once in a lifetime storm.

SPECIAL PRESENTATION

Montgomery General Hospital speakers were unable to attend our rescheduled meeting but wanted to let everybody know that there would be a grand opening of their new Emergency Room shortly that they were hoping to invite GOCA board members to attend.

Update on Olney Farmers Market and their search for a new temporary location

Janet Terry was very happy to report that as of the day prior to this GOCA meeting a location had been found. Thanks to some very hard work, Montgomery General had agreed to the Farmers Market using the area in front of the Thrift Shop. Neighbors in the surrounding areas had been approached and there had been nothing negative said but Janet was able to report completely positive feedback.

Janet asked that we get the word out of the new location and that the market was set to open for a new season on Mother's Day. It was hoped that this time there would be a meat farmer in attendance.

Janet wanted to publicly thank Montgomery General for all their help in securing this new location and wanted to thank Peter Mong who had provided the attorney and paid \$1500 personally to the attorney. Janet said that as a result of this new partnership with the hospital it was hoped there would be a Get Fit component and was excited about announcing more details of this in the future.

We were all asked to look out for information regarding the main fundraising event of the Olney Farmers Market which is their Farm to Table Dinner. This year it will be held in Laytonsville featuring all farm fresh foods and weather permitting will be held outdoors.

Sharon wanted to thank everybody for their support in making her tenure as GOCA president so successful. Twice we had gone to bat for the ride on buses that serve our community and with the help of petitions, speakers at hearings, posters and signs, the community had rallied and the buses had been saved.

Sharon encouraged all those who were not members to join the OBX – Olney Brookeville Exchange yahoo group. The group had been started by Linda Silverstein also an award nominee and was now a group that had a membership of over 1000.

Finally Sharon wished Matt and the incoming board every success for their next year and hoped to see everybody at the GOCA Awards at Longwood Community Center on March 7 which was her last official event as GOCA President.

When asked Sharon did confirm that she will be running for the District 2 council seat against Mike Knapp and was making a formal announcement in the next day or two.
