

# Executive Board Meeting Minutes September 9th, 2014

## CALL TO ORDER

President John Webster called the meeting to order at 7:31 p.m., and the GOCA representatives, alternates, and members of the public then introduced themselves. A motion was made and seconded to approve the May 2014 minutes. The minutes were approved unanimously.

A motion was made was and seconded to accept the August agenda. The August agenda was approved with one vote against and one abstention

## PUBLIC COMMENTS and ANNOUNCEMENTS

The following announcements were made:

On September 18<sup>th</sup> there will be planning meeting for the Farquhar Middle School project.

A question was raised as to why the GOCA agenda from July, 2014 was removed from the GOCA website. The meeting from July was canceled because of a power outage, which resulted in the meeting never being called to order.

### **BRT RESOLUTION**

Lee Lofthus presented a power point presentation on combining three resolutions into one resolution. This was concerning GOCAs position on the BRT, Special Taxing districts and the grade separated intersection at routes 97 & 28. There was much discussion. A motion was made and seconded to accept the resolution. Much discussion followed. The following motions to amend were made, and all had a unique second. Discussion occurred after each motion was made:

**Motion one**: Add, in clause 1, that GOCA was opposed to all options except the "No Build" option. This motion passed by a vote of 20 for, 13 against with 3 abstentions.

**Motion two:** Modify the first "whereas clause" to state that the" SHA has not demonstrated that the Georgia Ave corridor BRT, to the Olney area, will improve mobility". This motion passed with 26 for and 11 against with 1 abstention.

**Motion three:** Add to the 3<sup>rd</sup> "whereas clause" the Olney Chamber of Commerce resolution to the GOCA resolution. This motion passed with 31 for, 5 against and 2 abstentions.

**Motion four:** Include in its entirety, the Olney Chamber of Commerce resolution to the GOCA resolution. This motion was withdrawn. The Chamber's letter will be added as part of the packet.

**Motion five**: Remove clauses 2, 3 and 5. This motion failed by a vote of 2 for and 37 against with no abstentions

**Motion six:** Add to resolve clause number 2 "SHA to include in their modeling study pass-through traffic from all directions". This motion passed with 27 for, 4 against and 4 abstentions.

**Motion seven:** Add, "whereas the May 14<sup>th</sup> SHA BRT Design Alternatives ignore the 2005 Olney Master Plan." This motion passed with 24 for and 6 against and 5 abstentions.

**The final resolution** was voted on, including the additional amendments. This passed, as amended, with 32 for and 4 against.

#### **CHICK-FIL-A PROPOSAL**

Stacy Silber presented on the proposed Chick-Fil-A development plan. The presentation was thorough. Questions were asked around pedestrian traffic, outside seating being effected by idling cars and parking.

#### TRAFFIC CAMERA TASK FORCE REPORT

Gary Manion provided a report on the work performed by the traffic camera task force. The task force is still waiting for information and will provide a final report with recommendations later this year.

### **OFFICERS/COMMITTEE/LIAISON REPORTS**

A motion was made and seconded that officer and committee reports be moved to the next meeting because of the late hour. This was approved unanimously
