### **Public Policy and Community Affairs Committee 2022-09-06 Meeting Report**

The 2022-09-06 Public Policy and Community Affairs Committee (PPCA) Meeting of the Greater Olney Civic Association (GOCA) was held online via Zoom and called to order at 7:00PM EST by Thomas Canavan, Chair, PPCA.

Discussion Topics:

- Public Safety Reporting
  - Established contact with 4<sup>th</sup> District. Commander Augustine is out of the office for training, but I heard back from Deputy Commander Douglas Miller. We hope to provide regular updates on public safety periodically throughout the year. Lt. Miller will be at the next PPCA meeting.
- Longwood Community Recreation Center
  - Established contact with Katie Dowdy, Manager Longwood Community Recreation Center. Thomas and Katie are scheduling time to discuss what activities are available at Longwood and how we can create more awareness for Olney residents and add offerings that would serve our community.
  - We also discussed reaching out to the library to join the PPCA meeting to contribute to discussion around extracurricular and weekend activities.
- Environmental Initiatives
  - Jen provided an overview of composting effort and provided several examples of scaling the program to include participation in county programs and collaborating with local restaurants and food trucks to generate enough food scraps to begin a collection.
  - Marc provided an overview of the Terracycle program which aims to send plastic items back to manufacturers.
    - He plans to set up a collection site at the Farmer's Market

Action Items:

- How can Green Olney receive funding for environmental projects from the Greater Olney Civic Fund? Grants for specific – Grant cycle coming up in the next month
- Request that GOCA shares a list of Terracycle items that can be collected at the Farmer's Market
- Can GOCA sponsor SSL hours as a non-profit for community-based initiatives, for example having student volunteers at the Green Olney tent during the Farmer's Market? Montgomery Serves – Officers, GOCA already.

Meeting Report**

Members: Kathleen Donodeo, Irina Norell, Bill Wanatosky, Jon Morrison, Mindy Badin, joined after the call, John Seng, chair

- Brief introductions for this newly reformed Committee of GOCA
- Discuss Committee vision/objectives and mission
- Current issues:
  - Discussed the current Olney police station location and development. Why not just use the old bank building.
  - Traffic issues, lights and timing. Traffic patterns. Mass transportation and bus. Curbs.
    - Reach out to and connect with authorities in our areas of concern. Embark on listening and sharing mission. Emphasize safety and gather data.
    - Example: Bus and transportation that don't make sense. What is mass transit solution? OLNEY is too "tight," and not walking friendly.
    - Downtown is not as safe as it should be. Cars turning. Has to be a way to make it safer.
    - Lots of accidents. Start a conversation. Anything done to make it safer.
    - Left turn signals (flashing yellow or red) vs full signalization
    - Centerline rumble strips
    - Panhandlers on Rt 108 and 97 intersection medians
    - Traffic light signal timing
    - Use of speed cameras
    - Each intersection is different. Get consistent approaches.
  - Bike riding is hazardous.
    - Improve safety.
    - County has put bikers in harm's way. Help and get part of the plan.
  - No pedestrian connection on Dr. Bird road. Lots of students from GC can't walk. No accident data. Not enough pedestrians crossing. Pedestrian master plan and biking master plan.
    - Complete streets - sidewalks and multiuse
    - Path network connectivity
  - Condition of roads
    - Roadway (re)surfacing
