February 12, 2019

CALL TO ORDER

ANNOUNCEMENTS

Alden English announced that Olney Help is celebrating its 50th Anniversary. It offers food, both non-perishable and fresh, to residents in need. It can also offer monetary assistance of up to \$400. Additional needs are addressed by making referrals to other agencies.

The Women's Board at MEDSTAR Montgomery is offering \$500-\$4,000 scholarships for students in the medical field.

REPORT ON THE EMERGENCY RADIO TOWER

- a balloon test was performed on January 26, 2019
- photos were taken
- another site has been proposed by a homeowner's association
- there has been a consistent lack of community involvement
- notifications were not timely or simply didn't exist
- it's unclear whether it's a done deal or not
- it's vital that people come to the informational meetings to express concerns
- question: have any environmental studies been done? (answer: probably not)
- on February 19, there will be a conference call with legislators regarding a written assessment
- there will be a Community Meeting about the tower on Tuesday, March 5, 2019 at 7:30 PM at Cashell Elementary in the All Purpose Room; 17101 Cashell Road; Rockville MD

- Greg Intoccia reported on the boundary assessment study
- school enrollment up
- there have been population shifts
- goal to present findings to school board by spring of next year
- much to be determined
- commitment to transparency
- should GOCA weigh in or not?
- we must inform ourselves

REPORT ON COMMUNITY FORUM FOR ACCESSORY DWELLING UNITS (ADUs)

- Dave Miller reported on the community forum held on Saturday, January 19, 2019
- Hans Reimer and several officials presented
- there was a large attendance
- affordable housing is an issue
- encouraging adult children and grandparents
- provide some income for the owner
- must have a separate entrance with a separate bathroom and kitchen
- ZTA zoning text amendment required
- talking about removing size limits, minimum distance for ADUs, changing number of parking spaces
- county is pushing for more of these
- house must be owner occupied
- maximum of 2 adults, no limit on children
- HOAs may add restrictions
- only one ADU per property
- must provide two additional parking spaces
- no short term rentals
- Habitat for Humanity is involved
- can submit written comments
- in the past GOCA opposed ADUs as a right rather than an exception
- not all questions were answered at the forum
- county regulations would override the HOA
- restrictions must be in the declaration filed in county records (covenants)
- GOCA will draft a resolution and vote on it at the next meeting

- there will be a public hearing on February 26, 2019
