# DRAFT Representatives Meeting Minutes

February 11, 2020

#### **CALL TO ORDER**

1<sup>st</sup> Vice President John Blachere called the meeting to order at 7:36 PM.

Alden English made a motion to accept the Agenda for the February 11, 2020 meeting. The motion was seconded and approved.

An amendment was made to Minutes for the January 14, 2020 meeting. On page 2, under "How to pay for these educational goals," second bullet point, it should read "no big increase in property or sales tax being explored." A motion was made by David Miller to approve the January minutes as amended. The motion was seconded and passed.

GOCA representatives, alternates, invited guests, and members of the public introduced themselves.

#### **ANNOUNCEMENTS**

- Paul Jarosinski has the petition for a group called Nine Districts for MOCO to get an initiative on the 2020 ballot in Montgomery County proposing changing the representation of the County Council from nine members comprised of five District and four At-Large Representatives to nine District Representatives (eliminating the At-Large Representatives)

# CHARTER REVIEW COMMITTEE PRESENTATION BY LARRY LAUER

- Larry Lauer is a member of the Montgomery County Charter Review Commission
- there will be Charter Review Commission listening sessions coming up (dates below)
- the Charter Review Commission is non partisan
- action can occur through the Charter Review Commission or by petition
- the Commission started looking at the structure of the County Council to see if it's still relevant to the County as it is today (this is separate from the Nine Districts for MOCO ballot initiative mentioned above)
- the population of the County has increased dramatically
- we now have about 70,000 people per Council District
- most Council members are elected from Down-County
- the Commission has studied the issue, done research and is still in the information gathering phase
- one study shows that when comparing Montgomery County to other local jurisdictions, it has the worst ratio of council member to residents ratio for 7 of 11 measures studied

- one question still being explored is whether Montgomery County should have At-Large Council members or not
- It's unknown how the Charter Review Commission (CRC) will come out on the issue
- it's important to participate

- we want a bigger stake in decisions
- working to get an overlay zone which would give us more of a role
