DRAFT Representatives Meeting Minutes March 10, 2020

CALL TO ORDER

Matt Quinn called the meeting to order at 7:33 PM.

A motion was made and seconded to approve the Agenda for the March 10, 2020 meeting with one correction. Under Transportation, the second line should read "moved down in the priority." The motion was seconded and approved.

An amendment was made to Minutes for the February 11, 2020 meeting. On page 1, under "Charter Review Committee Presentation by Larry Lauer," 7th bullet, it should read "we now have about 217,000 people per Council District." A motion was made to approve the February minutes as amended. The motion was seconded and passed.

GOCA representatives, alternates, invited guests, and members of the public introduced themselves.

HOUSE BILL 1628 – SALES AND USE TAX – RATE REDUCTION AND SERVICES

- bill to help fund Kirwan Commission goals
- Robin Manougian from the Community Associations Institute (CAI) spoke
 - CAI advocates for community associations
 - CAI opposed the bill
 - bill has been dropped
 - any services would have been taxed 5% (management services, lawn and pool services, etc.)
 - testimony was given from both sides
 - opposition was strong & helped get the bill killed
 - there may be another bill brought forward
 - HB 1354 luxury tax, taxing cleaning services and other "luxuries" 6%
 - what things are considered to be luxuries
- Gary Simon from Comsource Management also spoke
 - if you spent \$1 million for work (roof, etc.) you would be taxed for this as well as existing

services

- are gambling funds going to the education fund?

Paul Jarosinski noted that if this legislation passed, many HOAs like Cherrywood could hit the maximum allowable assessment in their Declaration documents.

- Eric Luedtke from District 14 spoke
 - school construction is a priority
 - spend approximately \$1 billion in next few years; money from the gambling "lock box"
 - Kirwan Commission goal to have world class schools
 - our economy should be rooted in knowledge
 - right now we're in the middle of the pack
 - HB 1628 was about the way we tax things
 - funding proposals include closing tax loopholes
 - taxes from various products such as tobacco products, digital goods, luxury services
 - support small businesses by taxing differently than as it's done now
