DRAFT Representatives Meeting Minutes September 8, 2020

CALL TO ORDER

Note: this meeting was conducted via Zoom and Live Stream You Tube due to the Coronavirus restrictions in place.

Matt Quinn called the meeting to order at 7:32 PM.

The September 8, 2020 Agenda and July 12, 2020 Representatives Meeting Minutes were approved.

ANNOUNCEMENTS

- Sidewalks from Olney to New Hampshire Avenue have been approved.
- Council ballot initiatives will include Questions "C" and "D" regarding the size and makeup of the County Council. "C" would have 7 Districts and 4 At-Large positions. "D" would have 9 Districts (and no At-Large representatives). If 51%, or more, of citizens vote yes on both, they would cancel each other out and the current configuration would stand.

MONTGOMERY COUNTY AT-LARGE COUNCILMEMBER ALBORNOZ ON USE OF FORCE BILL 27-20

- The bill was passed unanimously.
- Puts into law and codifies past practices in use in Montgomery County.
- Also includes elements to prevent problems we've seen elsewhere in the country.
- It includes new policies that will prohibit officers from using deadly force except as a last resort.
- Prohibits neck or carotid holds.
- Limits no-knock warrants.
- Requires officers to stop, or attempt to stop, the use of excessive force by another officer.
- Another bill adds 6 licensed social workers.

Questions for Councilmember Albornoz:

1. Carolyn Knight talked about her involvement for many years with the NAMI CIT

Program which offers classes for officers. When calling 911 for a mental health crisis, ask for a CIT Officer, let them know the nature of the crisis, and if there are weapons involved.

A: Albornoz responded that MCPD also has a renowned Autism Training Program.

2. Howard Greif asked about a separate issue regarding operating requirements for HOAs. Do community playgrounds and pools fall under the requirements set out by the state during the COVID crisis?

A: Montgomery County has a decision making tree that uses data. Dr. Travis Gales and Dr. Earl Stoddard are at the top of the tree. They take a look as changes are needed.

DR. GILBERTO ZELAYA, VICE PRESIDENT, MONTGOMERY COUNTY GOVERNMENT BOARD OF ELECTIONS

- Mail in ballots that have been requested will be sent out the last week of September through the first week of October.
- There will be 43 ballot drop boxes.
- Starting October 1, there will be eleven early voting centers opened. Others will be added.
- People may vote at any voting center in their district. The closest voting centers in Olney will be at Sherwood High School and the Sandy Spring Volunteer Fire Department in Sandy Spring.
- October 1, processing of mail-in ballots that have been received will begin.
