CALL TO ORDER

Note: this meeting was conducted via Zoom and Live Stream You Tube due to the Coronavirus restrictions in place.

Hilary Phillips called the meeting to order at 7:30 PM.

An update to the minutes from the previous meeting was requested, will be revised based on feedback and posted following approval. We did not vote on approval, asked to move to the next meeting.

NOMINATION

• Hilary Phillips brought forth nomination for Michael Jozaitis as Recording Secretary, seconded – approved as new GOCA Officer.

ANNOUNCEMENTS

- Bowie Mill Bikeway Project; GOCA has sent a letter in support.
- Project is a connection between two bikeways, the issue is a delay in planning (more than one year). Would put the completion year in 2030, 15 years from planned original start date. GOCA appealed to Montgomery County Council to see what can be done to accelerate/approve in current budget cycle; County thanks GOCA, agreed the project was on value, learned there was a budget gap and that it is a "worthy project" that should move forward.
 - o Delegate Eric Luedtke showed support for restarting Bowie Mill bikeway project, communicating w/ town county council in real-time.

 Howard Greif – question regarding COVID insurance claims "targeting associations," seeking understanding on "legal immunity for fraudulent claims" made on public safety,

- IE virus transmission occurring on property (IE clubhouse) owned by an HOA/association/or similar. Legislators to follow up.
- Ed Weisel question regarding police shooting statistics (recent Cashell lockdown).
 Legislators to follow up with any known data.
- Curtis Chappel question regarding child vaccinations requirements in schools TBD,
 Legislators to follow up with any known data.
- C. Gervais question regarding "Housebill 1337" IE basketball backboards, who
 overrides who when it comes to HOA vs county vs state for ability to permit basketball
 hoops during lockdown. Legislators commented HOAs will have discretion over this
 matter (IE there is some leeway).

 - Of the 35 associations that pay into GOCA, so far 20 have submitted (due date is June end of month); well on the way to collecting all due fees. Wants to get to 100% by end of June.

 - o Howard will bring forth a copy of documentation for review, will request a "vote of support that associations are not held liable for damages from COVID related cases."
