The agenda of the 2022-3-08 representatives meeting was approved

The minutes of the 2022-02-08 representative meeting was tabled until the 2022-04-12 representatives meeting.

Thomas Canavan and Matt Quinn were approved as officers of GOCA without objection.

Treasurer Duce introduced Jennifer Rusiecki and Amrita Ghosh, founders of Green Olney, who gave a presentation titled "Green Olney - green initiatives in the greater Olney area" which concluded with a question-and-answer session, including suggestions for ways to connect with the community.

2nd Vice-President Quinn introduced Danny Rubenstein, member, GOCA Transportation Committee, who gave an update on the Bowie Mill Bikeway CIP Update. He presented a letter GOCA sent to the County Council and County Executive in support of allocating funds for completion of the bikeway earlier than currently proposed.

President Rosenheim presented some background information on the County's general plan and then introduced Khalid Azfal, General Plan Project Manager, Montgomery Planning Dept, who gave a presentation titled "Thrive 2050 Update" which concluded with a question-and-answer session.

A Motion was introduced by Irina Novell that after having reviewed the PHED Committee draft of Thrive 2050, we have gained a clearer understanding of the goals and scope of this document. Therefore, we now understand that Thrive 2050 is a broad mission statement intended to guide development and growth in the County over the next few decades with admirable goals of creating successful, equitable, and sustainable communities all through the County, and will not, in and of itself, result in changes to zoning. Motion not seconded; motion failed.

2nd Vice-President Quinn announced that GOCA will sponsor County Council District 7 Candidate Events via Zoom on April 5^{th} and April 7^{th} , 2022.
