Olney Days 2022, Barbara Falcigno

- Eight different events make up Olney Days including Party in the Park
- 11,000 pounds of paper shredding during annual shredding event.
- 400-500 attendees for Joe's Ride
- Est. 6,000 at Party in the Park and estimated 10,000 visitors watched the fireworks
- Community Clean Up took place behind Olney Elementary and Nancy Way.
- Other events included Car and Truck Show and the Parade.
- Olney Days was supported by over 100 volunteers with no paid staff and expenses sponsored by our business community. In 2023 we hope every household will consider donating one dollar.

Old Business

Update on the Olney Town Commons Initiative by Alan Sachs from the Olney Town Center Advisory Committee.

- Growing recognition particularly through COVID that we need outdoor space to engage and interact with each other.
- Key challenges is identifying a space. Master Plan expectation was that commercial development would take place and it would be incorporated into that redeveloped space, but that's not happening. Brings us to where we are now looking for new ideas.
- One of the mechanisms is through placemaking to jump start progress, such as creating a space for everyone to imagine what a town commons would look like. Focus on a temporary space so people get engaged with the idea. Successfully implemented in other communities locally. County Planning has expressed support likely early next year.

New Business

Montgomery County Dept of General Services Affordable Housing Site Availability Initiative (Note: a DGS representative will attend the July 12th meeting to discuss this initiative – no action being taken at this meeting)

- Helene Rosenheim asked Dept. of GS to attend, educate us, but they informed us they are early in the process, so no analysis of the situation but will be available during our July meeting
- A representative sent talking points in advance and Helene shared them during the meeting.
 - o Collectively more than 100 responses\few weeks
 - o Helene incorporate additional responses
