Presentations

Robert Gonzales. Program Manager, Montgomery County Dept of Transportation, Sidewalk Program

- CIP level effort
- \$ 3-4 million each year approximately
- 5-6 miles of sidewalk each year
- 300 requests for new sidewalks each year, 20-25 completed each year
- During a Q & A period

- Emily Hrabak from Girl Scout Troop 264 asked if the Sidewalk Program could provide a crosswalk across RT 108 to the library and post office. Mr. Gonzales indicated that would have to be done by the Maryland State Highway Administration, District 3.
- Liam Strenkowski from Boy Scout Troop 264 asked what problems do they face when constructing sidewalks and what can young people do to help? Mr. Gonzales noted there are often problems with needing to remove trees, having to relocate utilities, and having to deal with mixed community response or community opposition to proposed sidewalk projects. He was delighted with the question about how youth can help and noted that one thing they can do is testify at public hearings in their communities re: proposed sidewalk projects.

N. High Street CIP Project, Helene Rosenheim, For the Olney Town Center Advisory Committee

- The complete project was approved in the last budget
- Funding for planning and design is allocated in FY22-23, Land Acquisition in FY23, Site improvement in FY23, and Construction in FY24-25
- Nothing for us to be involved with until 35% design stage
- Visibility issues, but possible solution could be a 3-way stop

Transportation, John Seng, Chair

- Our appreciation to GOCA President Helene Rosenheim and GOCA Transportation Committee
 member Mindy Badin of GOCA for testifying in person to Montgomery County Delegation to the
 MD General Assembly Tuesday evening Dec. 8 in Rockville Council office on behalf of legislation
 to install speed monitoring devices along the MD 200 Intercounty Connector. Were joined by
 GOCA Transportation Committee Chair John Seng and three other members of SafeRoadsMD,
 the MD Coalition for Roadway Safety, Inc., all speaking in support of this legislation. Bill number
 is MC 8-23, calling for four cameras on the ICC, of which only two would operate at any given
 time.
 - GOCA Transportation Committee will keep abreast of this bill's progress and future need for advocacy and outreach.
- MDOT Community Project Update Dec. 21 Project Update #1 (pdf file attached)
 - Project manager Christopher Bishop will present at future GOCA meeting once scheduled increased work is imminent.
- Re: Montgomery County traffic safety, Member of SafeRoadsMD Coalition participated in Montgomery County's virtual PAC (Policing Advisory Commission) Annual Public Forum on Traffic Enforcement, and he reported to John Seng:
 - I was there and was able to contribute. My basic point was that traffic enforcement saves lives, and if we need to make improvements to address community concerns, then we can do that but: (1) the police must be partners in that process and discussion; and (2) we cannot make their jobs more difficult than they already are, as there is already a serious safety situation on our roads. Plus I noted that recruiting for the police is way

down and we have too many vacancies, another sign of low morale stemming from the current situation. Raymond Lombardo (Coalition member)

- GOCA Transportation Committee members is recruiting additional members to the
 Committee. Projects rescheduling quarterly meetings instead of monthly, while continuing to
 carry out activities in between and connecting as needed and reporting monthly to GOCA Board
 meetings. Anyone interested in promoting Greater Olney road safety (motorist, bicyclist and

- Development of Vision and Mission underway. Will plan to present at GOCA February meeting.

Olney Chamber of Commerce, Terri Hogan, Exec. Dir

- Last month National Night Out received a national award
- Presented four \$2,500 checks to MCFD, MCPD, Noah Leotta Scholarship, and Park Police
- The Noah Leotta Scholarship is live on the OCC website and is open to any Montgomery County High School senior who is planning to enter a career in community service
